

Regulatory Deadlines Are Closer Than They Appear

Assess Impacts

- Complete any **remaining tasks related to the HTI-1 requirements** to ensure compliance and set a solid foundation for future updates.
- **Revise and reconstruct your 2025 roadmap** to incorporate the latest regulatory changes and prepare for the new standards.
- Stay alert for the **release of the HTI-2 final rule**, which will provide detailed requirements and timelines for the next phase of interoperability and e-prescribing standards.

Focus on HTI-1

- Ensure all interoperability requirements from HTI-1 are **fully implemented and operational**.
- **Update 2026 roadmap** to reflect the new requirements and timelines after HTI-2 final rule is published.
- **Begin upgrading client systems** to comply with the new HTI-1 standards and prepare them for future changes.

E-Prescribing Phase 1

- Start development for **Formulary and Benefit (F&B) version 60**, ensuring your systems can handle the new standards.
- Development for the **Real-Time Prescription Benefit (RTPB) version 13**.
- Development for **HTI-2** (estimated) to meet compliance deadlines.
- Ensure all necessary certifications are updated to reflect the **new standards**.
- Continue upgrading **client systems** to support the new e-prescribing standards and interoperability requirements.

E-Prescribing Phase 2

- Implement **NCPDP SCRIPT Standard 2023011** to ensure that your systems support updated prescribing, electronic prior authorization, and medication history standards.
- Obtain any **additional certifications** required for the new standards.
- **Last mile HTI-2** (estimated) to ensure full compliance with all interoperability and data exchange requirements.
- Perform the **final upgrades for client systems** to ensure they fully comply with the new standards.
